## **Bob Anderson, President**OSF HealthCare Saint Francis Medical Center

As a Healthcare provider, OSF Saint Francis Medical Center has been focused on the COVID pandemic for many weeks. We have an Emergency Operations Plan and a Pandemic Response Plan that we have activated and implemented for this COVID crisis. Our facility has been following CDC and IDPH guidance on responding to the Pandemic which has included actions such as cancelling all non-essential surgeries and other outpatient procedures and restricting visitors to the Medical Center.

Like all healthcare facilities we face challenges with providing the correct personal protective equipment to our staff, but thanks to our supply chain staff we have been able to maintain adequate supplies so far! Central Illinois has been blessed with a comparatively low positive rate compared to urban areas such as Chicago or St Louis. That means we have plenty of capacity at this point because we are not seeing the non-essential patients to make room for the COVID patients, and there just haven't been that many of them in our area at this time.

We do have some staff working from home. However, we have had to furlough a significant number of staff across our Ministry due to the financial impact that the Pandemic is having on the OSF System. We continue to deliver babies, treat trauma, stroke and heart attacks as we always have. The support from the community for our Healthcare workers has been amazing! We have had donations from so many area businesses as well as individuals of everything from homemade cloth masks to lunches for staff – and it is all greatly appreciated!

With the COVID-19 pandemic, I have volunteered to deliver food to pantries and other places as well as helping to get laptops in the hands of District 150 students. I also regularly check on friends and neighbors who are high risk. It is important for everyone to do their part, whatever that is. We will get through this!



#### Jonathan Williams, President, Peoria Market Commerce Bank

At Commerce Bank, we have been extremely busy meeting client needs with some needing financial help and others needing advice. This has been the busiest year of my career thus far, specifically in the last three weeks. Adding to our volume of traditional client needs, Congress passed a \$2 Trillion stimulus package to help the economy and keep people employed during this challenging time. Part of the stimulus was administered by the Small Business Administration (SBA), which included \$349 Billion for Payroll Protection Program (PPP) loans. The process to gain these funds required detailed information to secure a SBA 100% guarantee and potential

up to 80% forgiveness of the loan. Today, we awaiting guidance from the SBA on what will be required for the forgiveness process and exactly what mechanics the SBA will follow to do so.

Many banks, like Commerce, processed these requests around the clock, from early April until April 16th when all of the funds had been allocated – to give a little perspective, during that time: Commerce processed approximately 500 loans per day, while previously we processed 10 SBA loans per month on average. Additionally, Commerce secured SBA funding of approximately \$1.5 Billion for 4,529 customers, with median loan size of \$64M. At the time of this writing, many bankers are awaiting an additional allocation of funds, potentially \$250 Billion, by Congress as many applicants were unable to get applications submitted or approved before the fund was exhausted. These additional funds will be used to keep many employed as it is unclear when we will return to our daily norm. Additionally, we hope everyone who can stays safe at home. Some of our staff are operating our branch network so customers can at least utilize services in a controlled environment safe for both our customers and employees. While the bulk of our staff are working from home, various roles require people to be present. We are providing extra resources to these employees to limit exposure & interactions with others.



#### Mark Yemm, Sr. VP Fondulac Bank

We are in the midst of the \$350 billion government stimulus package process, which has been more than challenging. As of mid April, that \$350 billion is all spoken for as Congress looks to increase it by another \$250 billion. I'm extremely proud of my bank and my co-workers who have more than answered the call as to putting in the time needed in order to process more than 1,400 applications that represents \$250 million that will be spent in our communities and region. This was done with no process, procedure or complete guidance until three days before the gates were to open. So those 1,400 SBA applications I mentioned were processed



from April 7th through the 16th, and typically we process 12 SBA applications per year.

From the point our US Treasury Dept. identified the banks as the way the funds were going to be handled and then put the caveat on those funds "first come first served," everyone was in hurry-up mode so a lot of handholding and heartburn wondering if they had been approved and worrying that the funds were going to be gone overnight. In my thirty years of banking, never have we had this type of challenge; but it sure makes you appreciate your co-workers and that roll-up-your-sleeve Midwest attitude that we sometimes overlook.

# Not-for-profit organizations step up to the COVID-19 challenge



#### **CityLink**

The health and safety of passengers and employees is the top priority for CityLink/GPMTD during the current COVID-19/coronavirus health crisis. Many essential workers and passengers needing access to essential services rely on public transportation. CityLink has been able to continue providing service, although currently reduced, for those that

need these services during the health crisis.

Some of the adjustments/changes CityLink has made in response to COVID-19 include: Taking extra precautionary measures to clean and sanitize buses and facilities daily; suspended fare collection on all transportation services (CityLink fixed route service, CityLift paratransit service, and CountyLink rural transportation service); reduced fixed route bus service on all weekday and Saturday routes with


The staff in the school programs have continued to service all of the public school children through check in calls, in person visits and teleconference as well as dropping off meals and computers. Our clinicians have continued to provide support to our Head Start and East Head Start programs, both staff and families. We continue to see people from all walks of life experiencing many challenges as it relates to shelter in place, social distancing or working from home and encourage all community members to promote self-care and wellness.



#### First United Methodist Church (FUMC)

First Church has been involved in supporting the Peoria area for years, particularly our neighbors in the center part of the city. Through our Loaves and Fish program, while normally serving a hot meal, worship service, and other needs every Saturday, we now serve a bagged lunch in addition to a bag of food from our pantry (non-perishables), fresh produce as available, and bread and bakery products.

Once a month we furnish hygiene bags with basic hygiene needs. There is still time to donate to our food drive through Saturday, May 16th. For this and other outreach programs through FUMC, such as Backpack Buddies at Lincoln K8, Neutral Ground, Benevolence Ministry, and Morton Square Soccer,





#### **Peoria Public Library**

Peoria Public Library is making every effort to stay engaged with patrons during this forced statewide closure. We are diligently promoting our digital library, which has nearly a million titles – including ebooks, audio books, graphic novels, movies,

documentaries, online classes and even television. This is above and beyond our databases, which are trustworthy resources for students doing online learning at home. As an example, with our Brainfuse database you can chat live with a tutor in real time for help on a variety of subjects. Others feature newspapers from around the world, scholarly journals and even genealogy information. We are also teaching our patrons how to use those resources with tutorials on our YouTube channel.

We're also adding Storytimes to YouTube so our patrons, especially our youngsters, can see a familiar face. Other YouTube offerings include booktalks and sneak peeks of our Local History collection. Meanwhile, we are using secured Zoom meetings to host book and film discussions. We're hosting weekly Facebook live sessions – same day and time – so our patrons know they can reach us in real time.

That said, we are answering patron phone calls and emails every day. When we realized that more and more people were interested in getting a library card, we added a temporary card they can apply for on our website. Our digital library is nearly as comprehensive as our physical collection, and we are doing all we can to connect our patrons to it.



#### **River City Labs**

River City Labs is a non-profit community of makers, hackers, tinkerers, and creators who share a physical space, tools, and thoughts.

#### **Peoria RiverFront Market**

The Peoria RiverFront Market is scheduled to open May 16 in a reduced capacity than its normal operation. The market will open in phases due to the COVID-19 pandemic and Illinois' shelter-in-place order extension. It will start with perishable produce vendors only and other vendors will be phased in using a fluid timeline as proper safety precautions are ensured. The Peoria RiverFront Association said it is dedicated to providing an outlet for local farmers to sell the produce they are currently growing and for our customers to purchase locally-grown food. Farmers markets have been deemed essential, and public safety is of utmost importance. The market will temporarily function as an "in-and-out" grocery store type of setting.
